Which is the purpose of personal data collection?

Personal data are processed with the purpose of managing the request for use the Computational Cluster KAIROS.

How long do we keep your personal data?

Personal data provided will be kept only for the time required to meet the purposes for which they were supplied and to determine the possible responsibilities that may arise from that purpose and from the processing of the information, considering also the periods established in the General Data Protection Regulation.

What is the legal basis that legitimizes the processing of your personal data?

The legal bases which legitimise the processing are collected in the General Data Protection Regulation (GDPR) 2016/679: Article 6.1.b) "processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract". Article 6.1.e) "processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller".

Do you have the obligation to provide these personal data and what are the consequences of not addressing it?

Provide personal data is strictly necessary to carry out the Computational Cluster KAIROS service request form and to accomplish the Comunidad de Madrid requirements related to cluster users. If personal data is not provided, due to the voluntary nature of the cluster request, the service would not be proceeded.

Who can be the consignee or receiver of your personal data?

Personal data will not be transferred to third parties including international data transfers, with the exception of the Computational Cluster KAIROS users report required by the Comunidad de Madrid.
